

POLICY TITLE: Support for Students

Purpose

Photography Studies College (PSC) is committed to ensuring its students are provided with the support and resources required to assist them to be successful in their studies.

Policy

PSC will ensure that support is available to students to assist them with successfully completing their units of study and that students are made aware of these support services throughout their study.

Procedures

Students At Risk of Not Successfully Completing Subjects

PSC will communicate with students identified as 'At Risk' in accordance with the Student Progress and Completion Policy and the Learning Access Policy to ensure they are aware of support services available to assist them in successfully completing their units of study.



Support Services Available to Students

PSC offers either directly, or through a third-party, a range of support options for students to assist in successful completion of their units of study, such as:

- Library services
- Student Wellbeing services
- Assessment guides
- Academic workshops

PSC will publish this *Support for Students* policy as well as more information regarding support for students on its website, in Student Handbooks, on the Student Portal in the Learner Management System and any other internal sites as deemed appropriate.

Definitions

'At Risk': At Risk status means a student's poor progress in a subject, or a series of subjects/units, is placing them in danger of failing that subject/unit (or subjects/units) and not being able to progress further.
